Dear Homeowner:

Since 1996, the Airport Noise Management System has enabled the City of Chicago to monitor the amount of noise generated from aircraft operating at Chicago O'Hare International Airport. The portable noise monitors allow us to provide you with specific information on aircraft noise levels at your home during a sample two-week monitoring period. This information is for your information only. **Due to strict Federal Aviation Administration (FAA) guidelines, the data collected by the noise monitor will not be used to determine eligibility for our sound insulation program.**

Once you have submitted the application, on the reverse side of this sheet, you will be contacted to set up a date for deployment. Since it is aircraft noise we are trying to measure, we ask that you try to avoid creating any other noise outside your home that may interfere with the measurements and not give a true representation of the actual aircraft noise levels. The monitor is very sensitive and capable of detecting all types of noises. The monitor is also a very delicate and expensive piece of equipment. Remember that while the monitor is on your property it is your responsibility. Also, please try to keep your yard clean for our technicians who will need access to your yard to change batteries or periodically check the equipment. Your cooperation and hospitality are greatly appreciated.

We have experienced problems with people damaging equipment by mowing their lawn. Please be aware that there is a cable running from the monitor box to the microphone through your yard. **DO NOT** mow your lawn while the monitor is in place! If you have a lawn cutting service, please have them suspend cutting until the monitoring is completed. If you must mow your lawn, please contact our office so we can inform you of a time when a technician would be at your home to change batteries and be able to move the equipment so that you may mow around it.

This report usually takes approximately four weeks to prepare and distribute. Once the monitoring is complete, we will provide you a detailed written report on the measurements.

**RESIDENTIAL APPLICATION FOR A PORTABLE NOISE MONITOR**  
**Chicago O'Hare International Airport**

The portable noise monitor is part of the Airport Noise Management System in place at Chicago O'Hare International Airport. We will place the monitor outside your home for a sample period of two weeks and will gather information regarding the location of your home in relation to the Airport, the type of aircraft operations that affect your home, runway use at O'Hare during the time of monitor deployment and noise levels gathered by the monitor.

I understand that this sample period of noise monitoring is for informational purposes only. These values do not reflect an annual average of aircraft activity similar to that of the City of Chicago's current noise contour and, therefore, are not used to determine eligibility for the Residential Sound Insulation Program.

I understand that noise monitoring equipment, especially but not limited to the cable that runs through the yard from the monitor box to the microphone, is extremely delicate equipment. I agree to take reasonable precautions to ensure that the noise monitor and cable are protected from damage while on my property. These precautions include, but are not limited to, not allowing children or animals near the equipment and otherwise prohibiting access to and activities near the equipment.
